






3. Department Chairs at my institution are genuinely concerned about my welfare.






4. Administrative/Managerial staff members at my institution are genuinely concerned about my welfare.



5. Counselors at my institution are genuinely concerned about my welfare.






15. I understand how to obtain counseling after an incident of sexual misconduct (that happened to me or a friend).






22. I have thought about & I have a general plan for protecting myself and those around me should extreme violence suddenly erupt.




23. I have a good understanding about what Timely Notifications are and when I would be receiving them.






24. This university would take the report seriously.




25. This institution would keep knowledge of a report of sexual misconduct limited to those who need to know in order for the institution to respond properly.






26. This institution would support the person making a report of sexual misconduct.




27. This institution would take corrective action to address factors that may have led to sexual misconduct.






28. This institution would take corrective action against a sexual misconduct offender.




29. This institution would take steps to protect the safety of the person making the report.






30. I would get help and resources for a friend who tells me they have been sexually harassed or sexually assaulted.




31. I would report students who engage in sexual harassment or unwanted sexual behaviors.






32. I would provide campus authority with information I have that might help in a sexual misconduct case even if pressured by my peers to stay silent.
