- People are questioning the need for a bachelor's degree- we will circle back in March.
- The Hanover report demonstrates the need for MSU Denver to examine graduate student fees
- Fee Philosophy Draft
 - Started by student affairs and added to by the Graduate Leadership committee
 - Committee believed some of the items proposed by Graduate Leadership was process

- Graduate Leadership wanted to see accountability via internal and external review by EAB
- Need to develop a process for the graduate fees
 - Can we modify or mirror the undergraduate process?
- Are there ways to consider the fee schedule based on access that students have based on being online or at night
 - There is a subcommittee working on this
 - Will make a recommendation on March 3rd

BACKGROUND INFORMATION FOR DISCUSSION WITH FINANCIAL AID

Good morning Graduate Program Council. During our Nov. 2019 meeting you requested specific information regarding the process/procedure used by the Office of Financial Aid regarding the recent distribution of 40k in scholarships to our graduate students. After a few months of consistent queries to our Financial Aid Office (see your email on 11/21/19 from me with the subject FYI for an example), I decided to (1) invite Thad to our Jan. meeting to get a response to our query and (2) instruct my office to conduct an independent investigation. After a thorough investigation by OGS we have identified the following:

GENERAL INFO.

- 1. Colorado funds two state need-based financial aid grant programs, the Colorado Student Grant Program, and the Colorado Graduate Grant Program ("Critical Career Graduate Grant"), for Colorado residents.
 - a. The Colorado Graduate Grant Program ("Critical Career Graduate Grant") has been in existence since AT LEAST 2015. I'm confident funds from previous years were used elsewhere and there is little point attempting to reclaim those funds...However, I thought it was important for you to know.
- 2. The Commission allocates Colorado Graduate Grant funds to participating institutions following the established methodology:
 - Participating State-supported four-year institutions, and approved private institutions will receive a flat payment from the state for each Pell Eligible student FTE enrolled in a critical career program.
 - Payment based on the average of the actual COA-EFC at each eligible institution as reported in SURDS. Eligible private institutions will use the average of a comparable public institution.
 - One question for Financial Aid is which programs are determined to be "critical career programs" and were the funds allocated to those students specifically?

STATE DISTRIBUTION GUIDELINES

- 3. Colorado Graduate Grant ("Critical Career Graduate Grant")
 Critical Career Graduate Grants are awarded annually. To be eligible to
 receive a Critical Career Graduate Grant, the student must meet the need-based
 requirements in 5.01.03 and the following minimum eligibility requirements:
 - Be a Colorado resident;
 - Be enrolled at least half-time (i.e., four credit hours per term);
 - Show documented financial need.

a. 5.01.03 Eligibility Limits for Colorado Student Grant

Public and non-profit private institutions are granted financial aid flexibility and will award students in accordance with institutional policies. The Graduate Council would like to know what institutional policy was used to determine the disbursement of funds. It is likely, however, that they followed the procedure below:

Proprietary institutions award state funded financial aid in accordance guidelines set forth by the state. To ensure that state need-based dollars are directed to eligible Colorado resident students who have the least ability to pay for their education; CCHE policy defines funding levels for awards granted at proprietary institutions. Using Expected Family Contribution, institutions will award need-based dollars to Pell eligible applicants. Other applicants will be considered only after meeting the need of Pell eligible applicants. Reasonable administrative practices, such as application deadlines, are recognized as realistic and appropriate. Institutions must fund Pell eligible students before consideration is given to any other students.

Pell Eligible: Students with the Least Ability to Pay Students with an Expected Family Contribution (EFC) between zero and 100% of that required for a PELL grant. The minimum undergraduate award for this group of students is \$1,000 or the maximum amount of unmet need, whichever is less. The minimum grant is \$1,000 to allow the funds to be spread among more students, accommodating budget reductions at the state level. The maximum undergraduate award is \$5,000. Awards may be pro-rated for part-time enrollment.

Level 2: Students with Documented Need and Moderate Ability to Pay Students with an EFC that is greater than 100% up to 200% of that required for the minimum Pell grant award. Maximum award for this category of students is \$2,500, or the maximum amount of unmet need, whichever is less. The grant can be pro-rated for part-time attendance.

Level 3: Students with Documented Need and Average Ability to Pay All other students who demonstrate financial need as calculated by the federal methodology. Maximum award for this category of students is \$500.

4. It appears to me, there is an additional option for graduate student funding via the Merit-Based Colorado funds. MY OFFICE WILL PUSH TO ENSURE WE ARE ALL MADE AWARE OF THE STATE QUALIFCATION STANDARDS FOR THIS. Colorado funds one state merit-based financial aid programs, Colorado Centennial Scholars and Colorado Graduate Scholars. State-supported merit aid is awarded annually. Students must qualify for these competitive awards each year by meeting all criteria. Institutions may adopt other eligibility criteria, in accordance with their institutional role and mission. The policy minimum standards only imply that a student may be considered for a merit award. They do not guarantee an award.

PROFESSIONAL JUDGEMENT-This "gray" area is where we as a Council must question the procedures used for our graduate students.

The state financial aid eligibility parameters are designed to apply to all financial aid recipients. This policy recognizes, however, that circumstances may exist in which the state financial aid parameters do not adequately address a particular student's situation. Financial aid administrators may exercise professional discretion on a case-by-case basis. The need for special treatment as well as the action taken must be adequately documented in the student's record.

Note: <u>Southern Cross University</u> will consider your background when reviewing applications. Typically, if you have five years' experience in a relevant field or other qualifications (like an Associate's degree or other certification) they will consider you for a postgraduate degree without coming from an undergraduate degree. They also weigh in your professional

experience, which is about seven years and over, for the possibility to receive credit or 'Advanced Standing' towards a postgraduate qualification.

Note: Simmons University

Nursing/Registered Nurse (RN, ASN, BSN, MSN) - Master

Current RNs with an associate's degree or nursing diploma might earn an MSN without a BSN at Simmons University. This nursing bridge program offers in-depth courses that offer you the ability to earn both degrees in potentially less time than it would take to earn each separately.

Note: <u>The University of Essex</u> is another example of a university that will consider your past experience in lieu of an undergraduate degree. Their online MBA program accepts students without a Bachelor's, as long as they can prove at least five years of relevant managerial experience

Note: AACSB does allow some MBA programs to accept students who don't have a bachelor's degree, under certain circumstances.
