A Degree Progress report or CAPP Report is required to ensure you are enrolled in the classes required for completion of your degree.

STUDY ABROAD:

If you are appealing because you have completed a STUDY ABROAD program and are still waiting for your grades to be recorded, you must provide an official or unofficial transcript of grades received abroad.

SELF-PACED COURSE:

If you are appealing because you are still in the progress of completing a SELF-PACED COURSE, you must provide a screen shot of your Blackboard portal showing what percentage of the course has already been completed. This percentage will indicate if you have completed enough of the course to qualify for financial aid.
