Your Free Application for Federal Student Aid (FAFSA) cannot be fully processed because your Selective Service registration information cannot not be confirmed. To be considered for financial aid you must submit this form along with supporting documentation of registration or of exemption from the Selective Service registration requirement.

This form must be received by our office at least 3 weeks prior to the end of the semester for which you are requesting financial aid consideration. Forms submitted without all required documents will be considered incomplete and will not be processed.

Please check the statement below that describes your circumstance and attach the required supporting documentation. Note: If our office is unable to determine that you were exempt based on the documentation you provide you may be asked to provide a Status Letter from the Selective Service System.

<input type="checkbox"/> I was born before January 1 st , 1960, and was not required to register for Selective Service.	Attach a copy of a state or federal identification or birth certificate confirming your date of birth.
<input type="checkbox"/> I have not registered with Selective Service because I am not yet 18 years old.	Attach a copy of a state or federal identification or birth certificate confirming your date of birth. <i>You must register for Selective Service once you turn 18.</i>
<input type="checkbox"/> I am currently in the U.S. Armed Services and on active duty, or am a veteran of active duty.	Attach a copy of your DD-214. (Note: National Guard and Reserves are <u>not</u> included in this exemption.)

<input type="checkbox"/> I am not required to register for Selective Service because I first entered the United States after I turned 26, or because I entered the United States as a lawful nonimmigrant on a valid visa and remained in the U.S. on the terms of that visa until after I turned 26.	<p>Attach documentation confirming your status as an exempt noncitizen. Provide: a valid passport, birth certificate, U.S. driver's license, or state ID card AND proof of immigration date into the U.S. from an entry date stamp on the I-94 form or in your passport, or a letter from USCIS indicating your entry date; OR, for those here on a valid visa between ages 18-26, a student visa (I-20) or other valid U.S. passport visa stamp on a foreign passport with an expiration date (dates must be from entry until after you turned 26). If you are unable to provide this documentation, you must complete the Appeal Process described below.</p>
<input type="checkbox"/> I am not required to register for Selective Service because the biological sex assigned to me at birth was female.	<p>Attach a copy of your birth certificate confirming the sex assigned to you at birth.</p>

APPEAL PROCESS: If none of the registration situations or circumstances above apply to you, or if you are unable to provide the required documentation, or if you failed to register for the Selective Service between ages 18-25, you have the option of appealing your financial aid eligibility. To appeal, you must first request a Status Letter from the Selective Service System (www.sss.gov). Attach your Status Letter to this form along with a typed statement explaining your failure to register and any documentation supporting your appeal. Your statement should address the reason you were not aware of the widely publicized requirement to register while aged 18-25. Our office will then review your appeal to determine if you are eligible for aid despite failing to register for Selective Service.
