

Constitution

Sport Management Club

Article I- Name

The official name of this organization shall be the Sport Management Club.

Article II- Purpose

The purpose of the Sport Management Club is to promote the major, professional development opportunities for students such as, resume and cover letter building, and networking opportunities with industry professionals. The group was founded to foster talent and help lead and prepare students for future aspirations.

Article III- Compliance

Upon approval by the Center for Student Activities and Involvement, the Sport Management Club shall be a registered student organization at Metropolitan State University of Denver. The Sport Management Club shall comply with all local, state and federal laws, as well as all Metropolitan State University of Denver regulations, policies, and procedures. Such compliance includes but is not limited to the University's regulations related to Non-Discrimination, Hazing, Commercial Activity, and Student Leader Eligibility.

Article IV- Membership

Membership of the Metropolitan State University of Denver Sport Management Club is opened to all students who follow the qualifications below:

1. Members will be determined based on attendance at meetings and events; Members can voluntarily withdrawal from the Sport Management Club at their own discretion at any time.
2. Any student pursuing a degree at Metropolitan State University, preferably Human Performance and Sport, Business Management, and Marketing Majors
3. Minimum of 2.0 GPA
4. Enrolled in minimum 3 credit hours per semester

Article V- Non-Discrimination

The Sport Management Club agrees to comply with Metropolitan State University of Denver's Non-Discrimination Policy stated below.

Metropolitan State University of Denver is an equal opportunity employer; applications from minorities and women are particularly invited. Article VI- Dues

There will be no annual dues to become a member to the Sport Management Club. We want to better prepare our members for future goals and aspirations.

Article VII- Officers

1. The elected officers shall be President, Vice President, Treasurer, and Secretary.
2. Two Representatives can also be elected if need be.
3. The term of office for each officer shall be for one year, starting in the fall semester and ending in the spring semester that follows.
4. This officer can then run again next year under a new position.
5. At the end of the spring semester, students can nominate themselves or their fellow peers for upcoming officer elections.
6. Elections shall take place at the end of the spring semester.
7. It is the duty of the President to attend and preside over all meetings.
8. The Vice President shall preside over all meeting in the President's absence.
9. It is the Treasurer's responsibility to manage the clubs financial accounts.
10. It is the Secretary's responsibility to document everything that the club does, such as:
 - Minutes during meetings
 - Event request paperwork
 - Financial request paperwork
 - Receipts
 - If an officer fails to meet his or her job duties for said position, the remaining officers have the right to vote said officer out of the SIO Club.

Article VIII- Officer Meetings

1. Officer meetings shall be held at least twice per month.
2. Meeting times and dates shall be scheduled at the sole discretion of the officer's.
3. Meetings will be held at the officer's point of choosing.
4. Elections will be scheduled at the last Sport Management Club meeting.

Article IX- Amendments

1. Amendments can be made at any time during the officer meetings.
2. This officer must make a motion to change the amendment.
3. The officers will then use a hand count to vote on the motion.
4. The majority of the vote will win.
5. In the event of a tie, the President will make the final decision.

Article X- Operations

1. Officers are elected by a vote by the current officers and members.

2. The election ballot will be a paper ballot election that will be tallied after all ballots are turned in and announced site on scene.
3. New officers will be elected the last meeting of the spring semester and will hold that position for one academic year.
4. Any member of the Sport Management Club is eligible for election.
5. Officers will assume their position immediately following elections.
6. Officers may be removed by the other officers based on a majority vote; in the event of a tie, the president will make the final decision.
7. Our advisor is there to resolve any conflict that may arise within the Sport Management Club.
8. Advisors are selected by the officers and voted on by a majority vote; in the event of a tie, the president will make the final decision.

Article XI- Finances

1. To finance our organization, the Sport Management Club will hold fundraisers at the Regency Athletic Complex, upon approval from the Athletic Department, as well as partner with local professional sports organizations to fundraise through ticket sales and on site fundraising at local venues.
2. The President and Treasurer shall have access to the financial account.
3. Any expenditure must be presented to the board by any officer.
4. Expenditures will be approved by a majority ruling vote.
5. All expenditures must be utilized in the best interest of the club and its members.

Article XII - Adoption

This constitution shall be the official Metropolitan State University of Denver Sport Management Club upon official registration with the Office of Student Activities.
