## **Important Notes for Students:**

Student's Name:

Until you reach Good Standing for Financial Aid, you will be required to complete this form with your academic advisor each semester. If you fail to meet the outlined requirements, you will not qualify for future financial aid until you achieve Good Standing for Financial Aid on your own. If, however, you encounter new extenuating circumstance(s), not reported in prior appeals, an additional appeal would be appropriate and may receive consideration.

You have the option to attend MSU Denver and pay your tuition and fees using your own funds until you achieve Good Standing for Financial Aid without submitting an appeal.

In accordance with federal regulations, if you will not complete your degree or meet GPA and/or minimum completion standards before reaching your program's Maximum Timeframe (typically 180 total credits attempted), your appeal cannot be approved. In other words, you have to be able mathematically to reach the GPA required for graduation within 150% of the number of credits required for graduation.

There are lifetime limits to federal and state financial aid. Students who receive financial aid and do not progress towards their degree may exhaust their aid eligibility before finishing their degree program. Research demonstrates that students who do not finish their degree struggle to repay their student loans.
