ASWB owns and maintains the social work licensing examinations that are used to test a social worker's competence to practice ethically and safely. The Examination Committee meets up to four times a year to review questions for the exams. Exams are administered throughout the year at secure test centers in North America and abroad.

Services to member boards include the Approved Continuing Education program; board services providing exam preapprovals, license application processing, and CE audits; the Public Protection Database, and Look Up a License.

Colorado Department of Regulatory Agencies (DORA)

The Colorado State Board of Social Work Examiners regulates licensed social workers and clinical social workers in the State of Colorado. Board activities include the review of licensure applications, complaints, and enforcement of disciplinary actions against violators of the Mental Health Practice Act or Board Rule. The Board is made up of seven members, three public and four professionals, who meet six times per year.

DORA is responsible for licensing social workers and all other mental health professionals in the state of Colorado, and for overseeing and regulating the practice of psychotherapy (as well as other social work practice activities covered under the Mental Health Practice Act).
