
OSRP Proposal Development Specialists will conduct targeted funding searches for you. To request this assistance from OSRP staff please complete the online **Research Request Form**.

OSRP offers multiple resources for grant funds prospecting. These include the Pivot database, featuring 25,000 records representing over 400,000 opportunities worth over \$33 billion, and the AASCU Grants Search which includes 2,000 private and federal funding opportunities screened for recurrence and for higher education eligibility, as well as a library of successfully funded proposals. Sometimes it's easier to go directly to the agency site if you know which agencies might be good prospects for your project, for example HHS and HRSA for Health Sciences, Department of Education for the School of Education, etc. Most of these agencies also offer the ability to sign up for their grants funding email blasts. Links to the most commonly requested agencies are available on the <u>OSRP website</u>, as well as being searchable in the <u>Grants.gov database</u>.

What is the IRB and do you need it?

MSU Denver's Institutional Review Board (IRB) provides ethical oversight to all research involving human subjects performed by MSU Denver Faculty and students. Our board consists of 11 members, with varying backgrounds across campus. We do our best to provide representation of all groups which make up our student and faculty populations.

Not all research requires IRB review, which can cause some confusion among researchers. The Human Subject Protection Program (HSPP) is designed to help navigate you through this process. The following three questions are a good starting point to determining if your project requires IRB review:

- 1. Does this project involve a systematic investigation (research)?
- 2. Does this project involve interaction with Human Subjects?
- 3. Does this contribute to generalizable knowledge?

If the answer is 'yes' to more than one of these questions, you should be contacting the HSPP to get started with the IRB process.
