# Western Regional Graduate Program (WRGP)

#### What is WRGP?

WRPG is the Western Regional Graduate Program, a program of the Western Interstate Commission for Higher Education (WICHE). Through WRGP, students in western states/territories (AK, AZ, CA, HI, ID, MT, NV, NM, ND, OR, SD, UT, WA, WY, American Samoa, Commonwealth of the Northern Mariana Islands, Federal States of Micronesia, Guam, Republic of the Marshal Islands, and Republic of Palau) may enroll in certain graduate programs at a special graduate rate. ## **WRGP Eligibility**

WRGP is open to students who meet both MSU Denver Graduate admission and WRGP program requirements. Qualified students must apply for WRGP by census date of the first semester by completing the WRGP application and show that they are residents of one of the WICHE partner states.

By requesting the WRGP program below, you are indicating that you are not a Colorado resident and will not establish Colorado residency during your time of attendance at MSU Denver. If you plan on establishing residency in Colorado and would like to petition for in-state benefits at MSU Denver during your time of attendance, it is recommended you do not participate in the WRGP program. WRGP students who change their residence to Colorado lose their WRGP eligibility the following semester, but do not become eligible for in-state tuition rates until one year after establishing Colorado domicile and one year after discontinuing their WRGP status. Because students in graduate programs are deemed to be independent, the WRGP student seeking to change domicile to Colorado must show a change of the students' residence.
