SOE at a Glance

MSU Denver School of Education Student and Program Data as of Census Date, Fall 2023

More than 1,250 MSU Denver students are enrolled in School of Education programs and taking classes in Fall 2023.

As of census date, our student population breaks down as follows:

- 519 students are declared in SOE undergraduate majors
- 322 students are declared in non-SOE majors leading to licensure
- 31 post-baccalaureate students are seeking licensure
- 31 students are enrolled in the Master of Education in Curriculum and Instruction program
- 113 students are enrolled in the Master of Arts in Teaching program (58 of whom are also enrolled in the Alternative Licensure Program)
- 95 additional students are enrolled in a post-baccalaureate Alternative Licensure Program (*Note: data from ALP records as of 9-13. Totals may not match student headcounts from Fall 2023 SOE census file*)
- 84 students are undeclared with an interest in an SOE program
- 11 students are enrolled in an Individualized Degree Program associated with the School of Education
- 58 students are declared in SOE minors

More than \$103,000 in scholarships have been awarded to School of Education students so far this academic year.*

The bulleted list below shows the number of scholarship recipients from each program area. So far this year, money has been awarded to 19 students in varying amounts from \$500 to \$6,400.

Recipients by Licensure Area:

- Early Childhood Education: 8.82%
- Elementary Education: 38.24%
- Secondary/K-12 Education: 35.29%
- Special Education: 8.82%
- Other: 8.82%

*Note that most scholarships awards occur in fall semester for the full academic year, so numbers for spring may not change much or at all.

We have 98 student teachers and residents on track to complete their teacher preparation programs this semester.

SOE faculty spend significant amounts of time in Colorado schools and facilities each semester.

MSU Denver faculty are deeply involved in schools and other facilities that provide educational services to children throughout Colorado, particularly around metropolitan Denver.

Faculty Time Spent in Schools per Semester (maximum):

- Full-time Faculty: 260 hours
- Adjunct Faculty: 200 hours

Faculty activities in schools include:

- Teaching SOE classes
- Supervising SOE students as they teach PreK - 12th grade students
- Conducting professional development with teachers
- Providing advocacy for children and parents
- Meeting with teachers and administrators concerning joint initiatives
- Conducting research
- Volunteering in classrooms and offices

Our students spend a lot of time in schools, too.**

- Early Childhood: 800 to 1060 hours
- Elementary: 805 to 975 hours
- Secondary/K-12: 820 to 850 hours
- Special Education: 800 to 880 hours

* Many students exceed the number of required hours in the classroom for their program.
